

IMPORTANT NOTE **LED Light Installation** For P/Ns 140201-1, 140202-1, 140207-1 ONLY!

If you have purchased any of the part numbers above, you will need to install the LED light provided BEFORE installing this step on your vehicle. Remove the lock nuts from the wire assembly. Feed the wire through the front of the step. With the LED light up against the flat recessed area of the step, use the two lock nuts to securely tighten the LED light to the step.










ALL DRAWINGS ARE VIEWED FROM THE DRIVERS SIDE FROM UNDERNEATH THE VEHICLE


1. (NOTE: If your step kit includes an LED light, please refer to the important note on the other side of this instruction sheet before proceeding.) With a flat head screwdriver, remove the black plastic plugs filling factory holes as shown in this diagram.



2. With the hardware provided, use your 13mm socket wrench to securely tighten the step as shown in the diagram to the right.



3. Your step is now ready for use! If you purchased the step or steps with the LED light, now is the time to wire this light to your vehicle.



4. Repeat these steps for the Passenger Side of your vehicle if applicable.
